### **PLEDGE OF ALLEGIANCE**

Vice Chair McNary led the group in the Pledge of Allegiance.

### **Approval of Agenda**

It was moved by Davis and seconded by Bisset to approve the agenda as submitted. The motion carried unanimously. Gleason absent.

### **APPROVAL OF MINUTES**

It was moved by Leash and seconded by Bisset to approve the March 23, 2016 minutes as submitted. The motion carried unanimously. Gleason absent.

### **Public Comments**

Carolyn Wood presented the Art Deco book she had mentioned to the Commission at the previous meeting. She provided a brief history of Art Deco and gave examples of the main Art Deco buildings in the Gorge. She also presented pictures she had taken of Art Deco buildings in The Dalles.

There was a general discussion about Art Deco examples in the City. The Commission also discussed the status of any proposals regarding a new high school and potential plans regarding the current high school which is a Historic Building.

### **Pioneer Cemetery**

Hert told the Commission that the Army National Guard had approached her about the possibility of them taking over the maintenance of the Cemetery. She also told the Commission that there would be a plaque noting the maintenance partnership between the National Guard and the Historic Landmarks Commission.

Bisset told the Commission that to her knowledge there was only one veteran buried at the Cemetery.

There was a general discussion about what military presence existed in the area and the possibility of more military veterans being buried in the Cemetery.

Hert updated the Commission about upcoming maintenance work at the Cemetery.

### **Staff/Commissioner Comments**

Hert told the Commission that there had been some minimal modifications to the original façade changes the Commission had previously approved regarding the Craig Building. She also showed the Commission a picture of the fire escape that had been painted bright yellow.

Davis commented about the view of Mount Hood from the river. He specifically mentioned that the view was obstructed by billboards and that visitors coming in on the tour boats had voice complaints.

There was a brief discussion about the aesthetic progress made over the years by the Cherry Growers at their facility.

Some of the Commissioners attended the Civic Auditorium's open house. There was a general consensus that the event did not have positive attendance and some ideas were shared as to how to increase participation in the future and increase historic awareness and participation in general.
